Vide reference No. 1 cited above, System Integrators (SIs) and vendors were required to get the CELC kit comprising of Tablet Computer Android platform and Single Finger Print Scanner device to be tested at UIDAI ROs/Tech Centre for interoperability and compatibility with the latest UIDAI's Child Enrolment Lite Client application. Subsequently the certificates were issued with concurrence from UIDAI Head Quarter.

Consequent to the changes in the policy, the revised specifications for CELC were issued vide reference 2 cited above and any instruments/combinations compatible with the latest version of the client are permitted for operating the CELC. Accordingly, the requirement to approach the UIDAI RO/Tech Centre for kit certification has been dispensed with immediate effect.

In view of the above, it has been decided that all the device/kit certification issued by UIDAI till date stands cancelled and Registrar can procure the Mobile / Tablet / Biometric device from with minimum specification (or higher) as per ref (2) through the GEM portal.

Ref. : Circular No. 4(4)/57/122/2012/UIDAI/Pt dated 31/12/2018

Vide above referred circular, System integrators (SIs) were required to get Aadhaar enrolment kits comprising of specific make and model of devices, tested and certified at any of the Regional office/ Tech Center of UIDAI for its interoperability with ECMP and the devices. After successful testing, a certificate is to be provided to SIs in the prescribed format.

2. In similar exercise, it has been decided that ROs/ Tech Center shall also carry out testing of CELC Kit consisting of set of hardware devices required to carryout successful Aadhaar enrolment and Update. The CELC kit comprising of following devices that may be tested for interoperability and compatibility with latest UIDAI's Child Enrolment Lite Client (CELC) application :
